The organization's primary performance measures are sentinels placements, overhead expense ratio and fundraising expenses. Placement performance is subjective, but requires that the organization continue to maximize the number of successful placements each year. The organization's target for 2010 is 15 placements. The organization presently has 45 Sentinels who have been placed since the inception of the program in 2007. The organization benchmarks its financial measurements to the guide of the American Institute of Philanthropy (AIP). Their target is 60% or more spent on program services. AIP's target for fundraising effectiveness is that fundraising expenses account for \$35 or less for every \$100 raised.

Note 1: In 2008 a major donor agreed to make a \$500,000 donation to the foundation based on certain conditions. Those conditions being substantially met as of December 31, 2008 resulted in recognition of this expected donation as a contribution receivable. In 2009, the expected amount was reduced to \$250,000 and further conditions were imposed based on actions to be taken in 2010. A \$500,000 loss was recorded on the statement of activities for the year ended December 31, 2009, reversing Pledges and grants receivable for the year ended December 31, 2008. This reversal resulted in \$500,000 loss recorded in 2009 that had effect on the following lines: contributions, total revenue, net income, total assets, net assets, public support and total support.

Note 2: It is the policy of the Sentinels of Freedom Scholarship Foundation that no scholarship will be awarded unless the Foundation has the funds on hand to meet its financial commitments over the life of the scholarship period. Since the Foundation has awarded a large number of scholarships, a considerable amount of funds are held in bank and investment accounts to ensure that all commitments to scholarship recipients will be met.
